Site inspection following report of small scale paper fire in portacabin which was attended by FRS (NRW attendance not requested).

NRW officers had spoken with Site manager and TCM of SIMS Neath site Richard Morgan to confirm that they would be undertaking a site inspection of the site.

On arrival the site was closed and a new padlock installed on the gate.

To the left of the gate (facing the site) there is no fencing in place which does allow unauthorised access to the site.

D1 Site Security.

Under **condition 1.1.1 (a)** the operator is required to manage and operate the activities in accordance with a written management plan that identifies and minimises the risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances closure and those drawn to the attention of the operator as a result of complaints.

Under Section 7 of the EMS that NRW holds on record, it states that the site is surrounded by a palisade fence. As mentioned above, to the left of the entrance there is no fencing in place which has enabled unauthorised access to the site.

This has been scored as a **Category 3 breach of permit.**

Please ensure that actions are taken so that the site operates in accordance with the EMS.
