A routine inspection was undertaken on the 7th March 2019 by Liane Bacon-Weekes. It was an unannounced inspection and focussed on the operational area of the site. Mr. Andrew Thomas and Mr. Jonathan Davies were present during the inspection.

Inspection findings

The operational area was inspected, and other than some minor housekeeping issues (see below) no permit breaches were identified at the time of the inspection.

Spillage prevention

During the inspection, it was evident that there had been a small oil spill which was addressed whilst I was on site. All measures should be taken to prevent spillages from occurring; enough time should be allocated for fluids to sufficiently drain from vehicles. Top yard

As discussed, the top yard is not within the boundary of the EPR permits and therefore you are unable to store waste in this area. At the time of the inspection a skip of tyres was present, and you were advised to remove this. It was noted that you would register an exemption in the area to cover any low risk waste storage activities.
