A routine inspection was undertaken on the 30th January 2019 by Liane Bacon-Weekes. Present during the inspection was Penny Weaver (Site Supervisor and TCM).

At the time of the inspection no permit breaches were identified, site was clean, tidy and well organised.

Comments from previous CAR

- Site drainage and infrastructure needs to be repaired to ensure that it remains impermeable and sealed.

Infrastructure and drainage works have been completed, and it was confirmed that the pooling is the result of tidal water backing up the system and not a sunken drain that was previously thought. Improvements have been made which has significantly reduced the issue but has not completely resolved it. It was noted that there are plans to sink an additional drain to help drain the water.
