4. Details of our assessment

Introduction

This Compliance Assessment Report (CAR) is an assessment of the monitoring results submitted by FCC Environment (UK) Ltd (the Operator) to cover the Quarter 3 (Q3) July to September 2025 Reporting Period.

Scope

The following monitoring data has been assessed within this Compliance Assessment Report (CAR):

- Pwllfawatkin Q3 Data 2025
 - Excel Data – Leachate Levels.
 - Excel Data – Point Source Emissions to Air.
 - Excel Data – Point Source Emissions to Water.
 - Excel Data – Groundwater Quality Monitoring.
 - Excel Data – Perimeter Landfill Gas Monitoring.
 - Excel Data – Leachate Quality.

Quarter 3 2025: Monitoring Submission Review

The monitoring data for the period Q3 2025 was submitted by the Operator on the 21st of October 2025. The submission was within the specified timeframe (within 28 days) and contained all informative requirements in accordance with permit condition 4.2.3.

Leachate Level Limits

Limits regarding leachate levels associated with the landfill cells are specified within *Schedule 3: Table S3.1* of the permit.

Leachate levels throughout Tip were all reported as compliant by the Operator.

The Operator was unable to monitor leachate levels in PWLMW4NB on the 17th of July 2025 as this was before the retrospective drilling works which were undertaken in August (contained within the CAR_NRW0049743). Subsequent monitoring events at PWLMW4NB were both reported as compliant by the Operator.

Point Source Emissions to Air

Air emission parameters and limits are specified within *Schedule 3: Table S3.2* of the permit. Monitoring of emission point A2 is an annual requirement as specified by permit condition 3.5.1b.

Within their Q3 report, the Operator has also submitted Oxides of Nitrogen (NO_x) and Carbon Monoxide (CO) monitoring results which were collected on the 4th of July 2025. These results (post tuning) were noted as being within the permitted levels outlined within the EPR permit.

Point Source Emissions to Water (Other than Sewer)

The parameters and limits regarding point source emissions to controlled waters are specified within *Schedule 3: Table S3.3* of the permit.

There were no reported exceedances of the specified emission limit values (ELV) to controlled waters throughout Q3.

Groundwater Quality

The parameters and associated ELVs regarding groundwater quality are specified within *Schedule 3: Table S3.4* of the permit.

Within the submission, the Operator reported a singular exceedance of permitted ELVs. This is detailed within Table 1 below:

This exceedance appears to be sporadic, with the previous occurrence recorded on 9th of December 2024. The Operator has previously conducted an investigation into the cause of elevated ammoniacal nitrogen levels at BH11B, which was submitted to NRW on 29th of April 2024. The investigation concluded that no definitive link could be established from their investigations.

A Schedule 5: Notification was submitted on the 31st of July 2025, in accordance with permit condition 4.3.2. Within this submission, the Operator has indicated the presence of a mine adit in the vicinity of WBH11B, which they suggest influences local groundwater chemistry. However, no supporting evidence has been provided to NRW to substantiate this claim.

Compliance:

Permit condition 3.1.1 below states:

'The limits in Schedule 3 shall not be exceeded.'

The Operator has failed to adhere to the permitted groundwater ELVs which are specified within *Schedule 3: Table S3.4*. This is a contravention of permit condition 3.1.1, and consequently, a non-compliance score of C3 has been allocated against non-compliance criteria IR3A(1) – Emissions to Water.

Compliance:

FCC Environment is to adhere to the limits that are specified within *Schedule 3* of the EPR permit. Should there be indication of an increasing trend in pollutants within groundwater boreholes, the Operator must investigate without delay.

Further groundwater monitoring requirements are outlined within *Schedule 3: Table 3.7*. The Operator fulfilled monitoring frequency requirements in accordance with permit condition 3.5.1c.

Perimeter Landfill Gas Monitoring

The parameters and associated limits regarding landfill gas within boreholes/probes are specified within *Schedule 3: Table S3.5* of the permit.

There were no reported exceedances of the specified emission limit values (ELV) regarding perimeter landfill gas throughout Q3.

Landfill Gas Field Monitoring

The parameters regarding the landfill gas field are specified within *Schedule 3: Table S3.8* of the permit. The Operator fulfilled monitoring frequency requirements in accordance with permit condition 3.5.1d.

Leachate Quality

The parameters regarding leachate quality are specified within *Schedule 3: Table S3.9* of the permit. The Operator fulfilled monitoring frequency requirements in accordance with permit condition 3.5.1a.
