4. Details of our assessment

A site visit by Natural Resources Wales (NRW) to Harp International (Harp) was carried out on 8th December 2025 to complete a waste management audit. Prior to the visit, NRW requested copies of the consignment notes from Quarter 1 2025 for review.

The site has a well managed EMS which provides a framework for the management of waste. Procedures and training are in place for most aspects and Harp personal were able to demonstrate a thorough understanding of the requirements of their permit and relevant legislation. EWC codes received and consignment note content were reviewed and found to be in compliance with the permit conditions and relevant legislation. The full report can be found attached to this CAR. Advisory actions have been included in the report.
