4. Details of our assessment

This compliance assessment report is being produced following an unannounced inspection of K Vaughan Metals, Llanidloes. The inspection was conducted by Luke Taylor (Senior Waste Regulation Officer) and Gillian Coates (Hazardous Waste Regulation Officer) of Natural Resources Wales.

The site was operational at the time of the inspection, and the weather was dry but overcast.

The officers were accompanied throughout by the site operator and Technically Competent Manager, Lee Vaughan.

W1A General Management

The continued competency certificate for Lee Vaughan is in date and valid until May 2026.

A walk around of the site was conducted, with several ELV's which were not de-polluted being stored on the impermeable surface. There was a quantity of scrap metal within the bay, along with several hard plastic skips being used to store segregated waste types.



There was a storage container for waste batteries removed from ELV's which was covered to prevent water ingress.

W4B Reporting

Waste returns have been submitted for the most recent calendar year, with returns for 2025 needing to be submitted to NRW by the end of January 2025.

A selection of waste transfer notes were reviewed, along with hazardous waste consignment notes, and found to be in order.

Other Observations

Work is still ongoing to clear the large amount of legacy waste remaining on the site from the previous site operator. There has again been a significant improvement, with most of this waste now cleared and removed from site. What remains is in the process of being sorted for removal.
