13 June 2019 12.00 – 13.00 A21 Continuous DAED High Temperature Fluid heater stack emission point exceedance of carbon monoxide hourly average of 230.5 vs 70 mg/m³ limit, which attracts a CCS3 non - compliance score.

Warwick indicate that the results were not known at the time of testing as taken as a spot sample. However, a Part A notification was not submitted until 24 September 2019, and the site is reminded that the operator 'shall notify without delay' once the test result is available.

The Part B notification dated 18 October 2019 - Measures taken to prevent recurrence states that:

Normal carbon monoxide emissions from the thermal fluid heaters are in the 20 mg/m³ to 40 mg/m³ region with the boiler engineering contractor carrying out routine maintenance so that the heaters operate efficiently and within the emissions limits. Following the monitoring result the contractor was brought in to adjust the heater controls and optimise the operation. It was thought that this was an unusual event and unnecessary to increase the frequency of heater maintenance and monitoring.

Action: Operator to review the notification procedure and heater maintenance schedule and submit copies to Natural Resources Wales by 31 December 2019.
