## 4. Details of our assessment

The purpose of report is to assess and record compliance with the Emissions to Water conditions relating to Event Duration Monitoring. Thank you for notifying us of an exceedance

On the 5th December 2025 you sent to us a Trigger Exceedance Notification (TEN) for CSO 49 Tir Einon, Llwynhendy. The TEN informed us that, on the 11th November 2025 the number of spills had exceeded the limit of 14 block counted spills within the Shellfish Season (16 Spills).

Action- You now need to ensure that you comply with Condition 3.1.2 (a) i) within 3 months of the trigger breach, submit an initial report to Natural Resources Wales for approval, with reference to the Best Practice Guidance in Schedule 4 Table 4.2, and, where appropriate proposals, including timeframes, for a full investigation into the operation of the overflow including a timetable for the investigation. The due date for this action is the 11th February 2026, which is 3 months from the date of the trigger exceedance.

NRW have issued CAR forms in relation to breaches of compliance with Spill Frequency conditions in 2024 (CAR\_NRW0043167).
