4. Details of our assessment

The non-compliance(s) listed above were identified by the Water Compliance Team when checking for quarterly Operator Self Monitoring (OSM) data submissions from Hafren Dyfrdwy (HD). These submissions are required at a minimum of quarterly as part of HD's

OSM water discharge permit conditions, but were submitted late on this occasion.

The result (No flow) for an OSM sample taken at Church Stoke STW (permit number S/01/56174/R) on the 20/05/2025 was submitted late on 20/10/2025.

Failure to report within the quarter is a breach of condition 4.2.2.

Non-Compliance category:

This has been classified as a category 3 non-compliance, as a late data submission means NRW cannot regulate properly. HD were eventually prompted to submit the late data.

Actions:

Please adhere to the conditions set out in your environmental permit.

We understand that the incident has already been discussed during an NRW / HD meeting on 3rd November, and that processes have been put in place to prevent recurrence.
