4. Details of our assessment

The non-compliance(s) listed above were identified by the Water Compliance Team when checking for quarterly Operator Self Monitoring (OSM) data submissions from Hafren Dyfrdwy (HD). These submissions are required at a minimum of quarterly as part of HD's

OSM water discharge permit conditions, but were submitted late on this occasion.

The results for an OSM sample taken at 2 results (BOD and TSS) for samples taken 10/07/2025 were submitted late on 20/10/2025 for an OSM sample taken at Llanfair Caereinion Stw - Fully Treated Effluent permit number S/01/56183/R.

Failure to report within the quarter is a breach of condition 4.2.2 .

Non-Compliance category:

This has been classified as a category 3 non-compliance, as a late data submission means NRW cannot regulate properly. HD were eventually prompted to submit the late data.

Actions:

Please adhere to the conditions set out in your environmental permit.

We understand that the incident has already been discussed during an NRW / HD meeting on 3rd November, and that processes have been put in place to prevent recurrence.
