### 4. Details of our assessment

A self report was made to Natural Resources Wales from Hafren Dyfrdwy/Severn Trent of a surcharging manhole that entered a tributary of the New Cut.

On 14 November 2025 at 11:14, a surcharge in the network via a manhole within the site boundary was identified during a routine visit by operatives, coinciding with Storm Claudia. The STW was overwhelmed due to significant rainfall, site flooding and the river backing up via the site outfall.

Two tankers were deployed to site to help to manage both the flows and drain. Tankers were in place from 13:02 on 14/11/2025 until 11:34 on 15/11/2025. The surcharge was stopped at 13:11 on the 14/11/2025.

Results submitted from HD to NRW via storyboard demonstrated no/minimal environmental impact therefore, this incident has been classified as a category 4.
