To maintain a reduced water level for dam safety critical work, taking place between 2nd Feb 26 31st Jan 28. The discharge will then be reduced to match the inflows to hold the reservoir at the required level. The discharge rate applied for is the maximum rate of the scour valve, the valve will only be opened to it's full extent if we were to experience a heavy prolonged amount of rain which would require the scour valve be fully opened to control the reservoir level

There is a scheme to improve the capacity and condition of the spillway at Nant Moel reservoir. The conditions under the spillway floor need to be confirmed, This will be achieved by carrying out intrusive GI works. In order to be able to work in the spillway safely the reservoir will need to be drawn down. To draw the reservoir down we will need to be able to use the scour valve to discharge water to manage the water level.
