#### 4. Details of our assessment

The purpose of report is to assess and record compliance with the Emissions to Water conditions relating to Event Duration Monitoring. On the 31st December 2025 you informed NRW by a Spill Frequency Trigger Exceedance Notification that there had been 17 spills. Condition 3.1.1 (Table S3.1) limits the spills from the asset at 14 in a calendar year.

I have assessed compliance with Condition 3.1.1 and found you to be compliant with this condition currently but you are required to ensure compliance with Condition 3.1.2 (b) as below:

- a. notify Natural Resources Wales of the Trigger Exceedance as soon as reasonably practicable (and no later than 4 weeks from the date of the Trigger Exceedance) in a format agreed by Natural Resources Wales;
- b. provide a reason for the Trigger Exceedance and a description of any remedial action undertaken or proposed. Where the reason/s for the Trigger Exceedance cannot be identified within the 3 months of the Trigger Exceedance the operator must provide a proposal with timeframes for a full investigation to be carried out to identify the reason/s for the Trigger Exceedance for approval by Natural Resources Wales;
- c. if a full investigation is required by condition 3.1.2 (b), implement the proposal as approved by Natural Resources Wales and provide to Natural Resources Wales a report which identifies the reason/s for the Trigger Exceedance;
- d. submit a plan with timeframes to resolve the reason/s for the Trigger Exceedance identified in 3.1.2 (c) for approval by Natural Resources Wales;
- e. the operator shall implement the plan as approved in condition 3.1.2 (d).

The due date for this action is the 9th March 2026, which is 3 months from the date of the trigger exceedance of 9th December 2025.
