4. Details of our assessment

Your Abstraction License has a requirement to submit annual abstraction returns to NRW, which were due for 2024/25 at the end of April 2025. We have not yet received your returns but the system indicates you started to submit but have not yet finalised the figures. Because they have not been submitted, this constitutes

a breach of your license conditions.

As a result, I am issuing this Compliance Assessment Report (CAR) with a Warning and a C4 breach.

Please ensure that you submit all outstanding abstraction returns when your next return is due for 2025/26. If you require assistance in submitting your returns, please contact the Water Resources Returns Team, who will be happy to help where possible

Your licence is issued to you under the Water Resources Act 1991 as amended by the Water Act 2003.
