4. Details of our assessment

This compliance report is the result of the site inspection of Coldbrook Road East 2 CSO (AN0393301) carried out by NRW officers Alex Grainger and Hannah Jenkins on 27/11/2025.

Arrived at site with DCWW and inspected the screens which looked to be clear with no debris / rag present. However, NRW were not able to inspect the rest of the asset due to the inspection covers being inaccessible. DCWW will need to regain access to these for future inspections.



According to DCWW storm overflow maps, this asset last went into spill on 14/11/2025 for approximately 9 hours.

Inspected the outfall which wasn't completely accessible due to overgrown vegetation, but looked clear from what could be seen. This assets permit states that this asset has one outfall to the Coldbrook, whereas the mapping system suggests that there are two outfalls. NRW request that DCWW confirm the number of outfalls for this asset.



Inspected the storm tank for this asset which looked to have built up silt within it. NRW request that DCWW provide the maintenance frequency for the storm tanks and advise that the built-up silt be cleared.
