#### 4. Details of our assessment

On 24 October 2025 NRW Officer Sally Wakeford attended at Nantycaws Phase 1 Landfill EPR/TP3298FH with Mostyn Wall and Benjamin Taylor. This was an unannounced visit. The visit followed an arranged visit to Phase 2. The weather ranged between bright and clear and heavy rain.

The visit was conducted with operatives from Infinis who undertake the maintenance and balancing of the wells for the gas plant on site.

A handheld Gazomat was used to undertake a survey of some of the wells. This survey would have indicated if any of the wells were leaking gas.

A number of leachate chambers were identified on the site, these were not opened, but the Gazomat was used to identify any escaping gas. These chambers were believed to be related to the leachate collection system.

1 leachate chamber next to well 0010 had a reading of 2354ppm of methane from the edge of the chamber. This high level of methane within the chamber could identify gas migration within the leachate, or an area where landfill gas is able to escape.

Gas infrastructure looked well maintained.
