## 4. Details of our assessment

We have been informed that returns data, for Water Resources Abstraction permit 22/59/4/0061, used to supply two fishing lakes at Cilonnen, Swansea, has not been received since 2019. Your permit requires that your abstraction is metered and that this data is recorded and sent to NRW upon request, this data has been requested annually since 2016 with the last request being made by letter on 28/04/25.
