Following a site visit to the asset, 12 months data (between the 1/8/24 and 31/7/25) was requested which has now been assessed.

EDM data shows that the asset spilt for 240 minutes for the period in question. During the period in question the flows did appear to reach the flow passed forward (7.79 l/s)
