Routine site inspection of the Morgan Sindall Construction Ltd treatment system. This

permit regulates the discharge of the site drainage into an unnamed stream of the Afon Cibi. The site drainage originates from a building site at King Henry VIII school site as it is being re-developed to include the construction of Abergavenny 3 -19, King Henry III school.

There were no issues identified during the inspection.
