4. Details of our assessment

Your Abstraction Licence requires you to submit annual abstraction quantities to Natural Resources Wales (NRW). Our records show that the returns for the 2024 reporting year have not been received.

In addition, NRW has not received returns for the following previous years: 2020, 2021, 2022, 2023, 2024 and 2025. This constitutes a breach of your Licence Conditions 8.1 (ii) - The Licence Holder shall send to NRW a copy of the records required by (i) above within 28 days after 31 March in each year, and also within 28 days of being so requested in writing by NRW.

As a result, we are issuing a Compliance Assessment Report (CAR) with a Warning and a C4 breach.

Please ensure that all outstanding abstraction returns are submitted when your next return is due for 2025/26.
