4. Details of our assessment

I (Environment Officer Gavin Dodd) arrived with Newport, Caerphilly and Blaenau Gwent Team Leader Kate Rodgers at the Newport Waste Disposal site on Wednesday 14th January at 10:30 to conduct an inspection regarding a discharge of trade effluent consisting of site drainage from Phase 2 Newport Waste Disposal Site to the Tidal River Ebbw (Permit Number AN0401301). Monitoring Technician Luke Embrey was also present.

The discharge was to consist of only trade effluent composed of site drainage. The discharge was inspected at the sample point. The discharge had a constant flow and appeared clear, with no suspended solids evident, no visible oil or grease and no odours. The water around the outfall was also clear and though there was some debris around the outfall this was likely deposited from the Ebbw at high tide. The discharge point was not inspected due to safe access being unavailable. It was also mentioned that in the last year, samples had been taken by the operators on 8 occasions with a log kept of occasions where samples couldn't be taken due to low/no flows.

- 2.) In addition to keeping a log on occasions where a sample can't be taken due to low/no flows, take photos on those occasions to support this.
- 3.) Investigate if there are any interceptors in place in the system.
