4. Details of our assessment

A site inspection of Jenson Metals EPR/CP3229EV was undertaken on 07 January 2026 by Natural Resources Wales Officer Alex Underhill. The purpose of the inspection was to undertake a final inspection prior to the surrender of the environmental permit.

A final Site Condition Report has already been submitted on behalf of the permit holder, dated 3.05.2025, with photographs contained showing clearance of the site.

I was accompanied on site by representative of Sycamore Environmental acting on behalf of permit holder.

W1A – General Management

The Environmental Permit for the site (ref: EPR/CP3229EV) allows for the storage and management of hazardous and non-hazardous wastes (e.g. automotive batteries, oils) and de-pollution and dismantling of end-of-life vehicles conducted entirely on impermeable surfaces designed to prevent leakage into soil or groundwater. During the inspection the site was free and clear of waste, and had been swept clean.

There was a small pile of stone approximately 4x3x2m from where a small wall has been knocked over. There was also a large PVC sign on the ground, belonging to “Jevington Logistics Ltd” who occupy a nearby yard. Neither of these were apparent in the photographs supplied from the SCR submitted.

The drains on site were clean and free of signs of oil or contaminants. The permit does not require any monitoring of the activities, emissions or the environment.

W2A – Permitted Activities

Following a review of the records held by NRW of the storage locations of the previous Operator it indicated that there are impermeable surface areas specifically constructed for battery and oil storage. These were found to be in good condition.

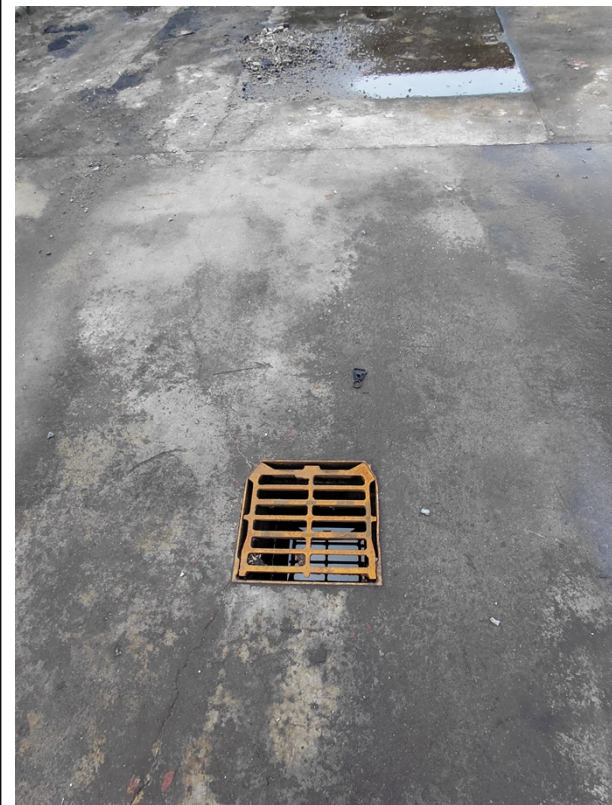
