## 4. Details of our assessment

### Purpose of assessment

The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter NRW) off-site assessment of odour from the activities permitted under environmental permit LP3135SB.

### Regulatory Context

This assessment was carried out following reports received by NRW of odour in the locality of the permitted site. Several of these reports suggest the permitted site may be the source of the odour.

The reports being investigated as part of this assessment are - Wales Incident Recording System (WIRS) references: 2510729, 2510732, 2510737, 2510739, 2510740, 2510750\*

### Assessment

A selection of off-site locations in the locality of the permitted site was visited, and an odour assessment was carried out.

The details and findings of the assessments are fully recorded in the document – '*ODOUR ASSESSMENT-FILENOTE-LB-20261204*'.

Please note: odour assessments were undertaken for a duration of 10 minutes at each location. Assessments were not undertaken whilst travelling between locations.

At the time of the assessments, either no odours from the activities were detected, or, odours from the activities were detected, but not perceived to be at a level likely to cause pollution.

'Pollution' is as defined for the relevant activity in *The Environmental Permitting (England and Wales) Regulations 2016*.

### Conclusion

Section '2.2.6 Odour' of the environmental permit lists Condition 2.2.2.1.

Condition 2.2.2.1 of the environmental permit states:

*The Operator shall use BAT so as to prevent or where that is not practicable to reduce odorous*

*emissions from the Permitted Installation, in particular by:*

- *limiting the use of odorous materials*
- *restricting odorous activities*
- *controlling the storage conditions of odorous materials*

- *controlling processing parameters to minimise the generation of odour*
- *optimising the performance of abatement systems*
- *timely monitoring, inspection and maintenance*
- *employing, where appropriate, an approved odour management plan*

*provided always that the techniques used by the Operator shall be no less effective than those*

*described in the Application, where relevant.*

At the time of the assessments, the Operator was assessed to have been complying with condition 2.2.2.1 of the environmental permit.
