4. Details of our assessment

This was an unannounced, site visit made by David Ellar and Alex Underhill of Natural Resources Wales (NRW). The purpose of the inspection was to assess compliance against the tier 3 bespoke Environmental Permit (RB3893HK).

The weather was fine but recent heavy rain had made the site wet.

Previous inspection:

No permit breaches were observed during the last inspection dated 15/06/2023 Please see Compliance Assessment Report CAR_NRW0042114 for further detail.

Permit Breaches:

No permit breaches were recorded during this inspection.

General observations:

The site was generally clean and well organised with good segregation of waste types. The hardstanding and treatment areas were in good condition and good waste storage practices were observed.

A small open top drum was visible on site and had been used for burning. The operator explained that no wastes had been burnt in the drum it was just used occasionally to warm up old engine parts (to aid in starting) in the recent cold weather. No evidence of burning of waste was seen. Fires are however not permitted on the site, please see condition 5.2.1 of the permit. The operator was advised of this condition and will not have any more fires on site.

Depollution of ELV's:

Several of the ELV's on the hardstanding area were inspected and were found to be depolluted to a good standard. No fluids were observed and no signs of spillages or contamination on the ground.

Technical competence:

Scott Appleyard is the current TCM for the site and holds the appropriate WAMITAB certification. Continuing Competence certificate was shown with expiry date of 02/12/2027.

Waste Returns:

Waste returns are annual and the site is up to date with them.

Permit:

The current permit for the site is old, it was issued in 2005 and has not been reviewed. The permit is missing several conditions that other similar modern permits have, such a requirement to have a Fire Mitigation and Prevention Plan (FPMP) and the requirement for the permit to be operated in accordance with a written management system (EMS) that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attention of the operator as a result of complaints. It is likely your permit will be reviewed in the future to bring it in line with other modern permits. The operator is advised to look into compiling an EMS for the site.
