4. Details of our assessment

Your Abstraction Licence requires you to submit annual abstraction quantities to Natural Resources Wales (NRW). Our records show that the returns for the 2024 reporting year have not been received.

In addition, NRW has not received returns for the following previous years: 2019 - 2023. This constitutes a breach of your Licence Condition 1.9.2.

As a result, we are issuing a Compliance Assessment Report (CAR) with a Warning and a C4 breach.
