4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised following a review of the Q4 2025 monitoring returns and annual review.

The Q4 2025 monitoring returns were received on 13th January 2026 for discharges from emission point W1 in compliance with permit condition 4.2.3. The monitoring was undertaken in accordance with permit condition 3.6. All reported parameters were in compliance with the Emission Limit Values (ELV's) applied by Permit Condition 3.1.2, Schedule 3, Table S3.2 (a).

Records of weekly visual checks for W2 and W3 emission points for Q3 2025 were also provided in compliance with permit condition 3.6.1, Schedule 3, Table S3.2 (a). Monthly meter readings for the borehole extraction were also submitted.

Annual review data was submitted on 13th January in compliance with permit condition 4.2.2.

There was a very slight increase in the number of birds slaughtered in 2025 from 2024 but energy and water use were comparable to 2024. There was a significant reduction in the number of chicken products produced in 2025 compared to 2024.
