4. Details of our assessment

The inspection was carried out by Selby Le Roux accompanied by Zoe Widlake, Matt Roberts and Ruth Anthony of DCWW. At the time of the inspection the RBC was out of commission as the shaft had broken and it was only being used as a primary settlement tank. Temporary biological treatment consisting of two mobile SAF tanks were being used to treat the effluent. The reed bed on site is no longer in use and the treated effluent now bypasses it before discharging to the river.

Access to the discharge point is possible and there was no sign of an impact on the river. There is a storm overflow at the works (BP0322901) which discharges to the river a short distance upstream of the final effluent point. There was no sign of any debris or sewage

fungus below the CSO.

No permit breaches were identified during the inspection.

Replacement parts for the RBC are due January/February 2021.

During the inspection it was noted that there was a sign on site stating that the final effluent conditions are BOD 40 mg/l. and SS 60 mg/l. but the correct conditions are BOD 52 mg/l and SS 40 mg/l. so the sign should be changed.

The flow at the time of the inspection was 2.5l/s and there was no storm discharge occurring.
