4. Details of our assessment

On the 04/11/2025 NRW officers visited The Black Cock Inn to undertake a routine monitoring/sampling check on the treated discharge from the package treatment plant (Permit no. WQD009196). Breaches of the following conditions were recorded.

Breaches

1. CATEGORY 3: Condition 3.1.1 – Visible oil or grease

There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.

- *Visible oil or grease: No significant trace present.*

Justification – During the visit, NRW officers noted the presence of oil and grease within the discharge. This is a breach of the above permit condition and has been assessed as a Category 3 (C3) breach.

Actions required by date specified

1. Improve operations to bring the discharge into compliance with permitted limits
2. Produce a report on why the system is not meeting limits of the permit

The deadline for the above actions is **19/03/2026**
