4. Details of our assessment

This compliance form is the result of a report of pollution submitted on 17/12/2025.

NRW received a report regarding the DCWW asset Trerhyngyll SPS discharging into the nearby watercourse.

DCWW attended site and confirmed the spilling of the asset into the watercourse. DCWW provided pictures of the discharge which showed very little debris present.

Ammonia samples were taken and showed the following results:

Upstream: **0.00ppm**

Direct from the overflow: **1.22ppm**

15m downstream: **0.26ppm**

This asset is known to spill during heavy rainfall and has had historic issues with hydraulic overload which cause it to spill. This site's permit does not allow for it to act as a CSO and is therefore spilling without consent. NRW have decided that this is non-complaint due to spilling in non-emergency conditions.
