CARS form generated following a notification being received by Natural Resources Wales that Operator Self Monitoring samples taken by Mott MacDonald Bentley Ltd at Llyn Celyn on the 09/01/26 had exceeded the limit.

The exceedance saw suspended solids of 76mg/l. The permit limit is 60mg/l.
