4. Details of our assessment

Final Warning

Alastair Krzyzosiak attended the hotel to chase a response to the previous two CARs which had gone unanswered. Several emails to multiple hotel email addresses also went unanswered since the previous site visit. On this occasion, AK met with hotel manager RCJ. It appears that there have been numerous staff changes at the hotel in recent months.

Hotel management / owners must comply with the actions set out in the previous CARs.

Failure to comply will result in further enforcement. This may include no longer being permitted to discharge wastewater from the site.

During discussion at the most recent meeting, it was mentioned that tankers are currently visiting the site weekly to empty the sewage treatment plant. This does not sound like it is part of normal operations. You must investigate the reasons for such frequent tanker visits and report back your findings. Any breakdowns or maintenance issues with the plant must be explained.
