### 4. Details of our assessment

Compliance inspection of Merthyr Dyfan Road CSO AN0104801, undertaken by Environment officers Harry Warburton, Hannah Jenkins, Leon Handley and Karen Bowen, accompanied by DCWW pollution technician. Weather at the time was cold and intermittent heavy rain.

The screen for this CSO was inspected and appeared in good order. The EDM monitor was also present and visible.



This CSO has an off-line storm storage tank with a permitted capacity of 290m<sup>3</sup>. The cover for the storm tank was lifted and appeared to be heavily silted, reducing the storage capacity below the permitted value before a storm spill occurs as per permit condition 2.3.1(b). It was not known when the storm tank was last inspected and desilted.



Actions:

- Conduct a desilt of the storm storage tank to allow for the permitted capacity.
- Provide information of when the storm tank was last inspected and desilted.
- Provide the section of the written management system for the maintenance of the storm tank, including information on the frequency of a de-silt.
