4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is to record the Natural Resources Wales (hereafter NRW) site visit to National Grid's Ty Coch Depot in Cwmbran on 6 January 2026. The reason for this visit was for the newly appointed Industry Regulation Officer, who is now responsible for regulating this site, to become familiar with on-site operations & activities and to meet National Grid staff.

Prior to this visit, Neil Griffiths reviewed a site drainage plan that was part of the Site Condition Report produced on May 5th 2015 by Paul Downing Associates, reference: WPD Surface Water Drain. The plan is on page 24 of this report. Please can you confirm that this is the most up to date drainage plan for the site. If it is not the most up to date drainage plan for the site, please can you send me a copy of the latest site drainage plan.

NRW met with National Grid and introductions were made. National Grid, amongst other things, gave NRW an overview of site operations, internal and external audit procedures, drainage inspection and maintenance arrangements.

National Grid also told NRW that other National Grid sites that held standard rules waste permits in Wales had not had a visit from NRW in a long time.

Following these discussions a site walkover was carried out.

During the site walkover it was observed that site drainage wasn't colour coded. It was suggested that labelling surface water and foul water drains could reduce the chances of pollution occurring during a potential oil spill, e.g., red for foul water drains and blue for surface water drains.

National Grid explained that site operating hours are 0800 - 1600, Monday to Friday and that the busiest time of day is usually 0800 - 0900.

Initial impressions were that the site was clean, tidy and well run.

Following the site walkover, NRW thanked everyone for their time and advised that the next site visit would probably be in quarter 2 of 2026/27. This visit is likely to be an audit of containment infrastructure, e.g., bunds to contain oil spills. Compliance with CIRIA 736, Containment systems for the prevention of pollution will be assessed.
