4. Details of our assessment**Wepa UK Ltd****EPR- EP3738NG**

This Compliance assessment report (CAR) provides a summary of the 'operator monitoring assessment' (OMA) audit undertaken at the facility on the 13th of January 2026, along with a list of the required actions.

An OMA audit was undertaken on the 13th of January 2026, this was undertaken as routine compliance work to assess the self-monitoring being undertaken at the facility for the point source emissions to water (the River Llynfi) at emission point W1.

The operator achieved a moderate score of 101 / 135 ~ 75%. The actions below have been issued to improve overall quality and assurance for some aspects. However, overall, the operator demonstrated relatively robust processes and procedures, good maintenance and calibration and compliant methodology. The full OMA report can be found as an attachment to this report.

Action 1 – Wepa UK Ltd – 23rd of January 2026: Wepa to complete the actions detailed in OMA 2A, OMA 3G, OMA 4A, OMA 4B and OMA 4C and provide confirmation and any requested documentation. **Due 31/05/2026**

OMA 2A - Ensure the sample probe inlet is appropriately positioned, in line with the guidance available for monitoring discharges to water, which can be located [HERE](#). Provide NRW with confirmation and photographic evidence once implemented.

OMA 3G - Ensure all contingency measures for continuous monitor failures are captured and detailed within a procedure. Any staff responsible for repairs should then be trained / signed off as competent against that procedure. Provide NRW with confirmation and copies of any relevant documents once completed.

OMA 4A - Provide NRW with confirmation and a copy of any participation certificate for the proficiency testing once completed.

OMA 4B - The operator to implement the following: 1: A documented review process for assessing data validity. 2: A documented procedure for investigating failures. 3: Analytical quality control charts for all analytical methods, such as Shewhart charts. Further information on analytical quality control charts can be found [HERE](#). Provide NRW with confirmation and copies of any relevant documents once completed.

OMA 4C - Ensure the training matrix is utilised and staff responsible for monitoring aspects receive training on the relevant procedures and this is captured on the training matrix.
