4. Details of our assessment

This Compliance assessment report (CAR) has been issued to document an Operator Monitoring Assessment (OMA) undertaken at the IQE (Europe) site in St Mellons. The OMA assessed compliance with emissions-to-air monitoring requirements under Environmental Permit EPR/KP3235SS. The assessment comprised a review of relevant documentation and a site inspection conducted on 17 November 2025.

IQE (Europe) operates a robust Environmental Management System (EMS), accredited to ISO 14001. However, the EMS requires amendment to ensure that all monitoring parameters are captured and that formal procedures are in place for the review of Site Specific Protocols (SSPs).

Action 1:

Ensure that the EMS includes all required monitoring parameters and a documented procedure for reviewing the SSP.

Status: Action complete.

Periodic monitoring is undertaken by accredited contractors, with samples analysed by accredited testing laboratories. Monitoring activities are largely compliant with applicable standards. However, issues were identified in relation to sampling platform length and the absence of a documented procedure addressing scaffolding safety.

Action 2:

Implement a procedure for the review of SSPs and monitoring reports to confirm compliance with the requirements of BS EN 15259. Where full compliance with BS EN 15259 cannot be achieved, a documented technical justification and action plan must be established.

Due date: 28 February 2025.

Action 3:

Update the EMS to ensure that sampling platforms are verified as safe prior to use, including appropriate arrangements for scaffolding safety.

Due date: 28 February 2025.

Quality assurance is supported through the engagement of accredited third-party monitoring organisations. However, improvements are required in the internal auditing of monitoring activities and the application of root cause analysis.

Action 4:

Ensure that internal auditing of monitoring activities is incorporated into the EMS, including provisions for corrective action and root cause analysis where non-conformances are identified.
