## 4. Details of our assessment

This Compliance Assessment Report is being produced following a review of the waste returns and Technically Competent Management (TCM) provision of Kirkhamsfield Depot, Newtown.

The review was conducted by Luke Taylor (Senior Waste Regulation Officer) of Natural Resources Wales.

### **W1A General Management - Permit Condition 1.1.4**

The above permit condition states that the operator shall comply with the requirements of an approved competency scheme. The continued competency qualification for the site TCM, David Gardner is in date and covers the level of activity taking place on site.

### **W4B Reporting - Permit Condition 4.2.2**

The above permit condition states that, within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter.

The waste return submissions for the site are up to date and the information contained within the latest returns is deemed compliant. For note, the site name is being recorded as 'Kirkhamsfield Newtown Gulley Waste Bays' on the returns, this should be the name of the site as recorded on the permit.
