4. Details of our assessment**Welsh Water Organic Energy – Tremorfa AD****Permit Number EPR-AB3093CA****Schedule 5 Notifications of Biogas release**

On the 9th of December 2025, Welsh Water Organic Energy (WWOE) notified (via email) Natural Resources Wales (NRW) through a schedule 5 notification of a release of gas from ‘mixer 1 service box’.

Incident 6th December 2025

WWOE submitted a schedule 5 notification to NRW detailing the event that occurred on site on the 6th December 2025. During the normal operation of the AD plant the operator detected some issues on their systems. The operator then stopped the feed to the digester as well as stopping the mixers to prevent more gas being produced. The operator had put the liquid gas seal in place. During this incident the service box on mixer one had failed due to damage to the guide bar and as a result the valve was in an open position and unable to close. This allowed biogas to escape to atmosphere. The operator estimates that around 200m³/hour of biogas was released. The composition of the biogas was approximately 59% CH₄, H₂S 178ppm, CO₂ 38% and O₂ 0.32%.

Following further investigations on the event, it was found that there was a failure on the captive nut of the pressure relief valve (PRV) not being secured in the correct position which subsequently allowed the biogas to escape due to there not being a secure gas seal. The part that failed was an internal fitment and would be only visible as part of an internal inspection/ maintenance visit and would not be visible for normal operations. However, the operator has the PRV serviced every 6 months by a specialist external contractor. To date there has been no issues with this during the operation of the site. Additionally, the service box is checked by site staff as part of their daily checks on site.

Action: Improve daily checks to ensure no failure occurs in the future, checks will be made during the next site visit in March 2026.

Non-Compliances

The fugitive emission of biogas is a breach of permit condition 3.2.1 which states:

“Emissions of substances not controlled by emission limits (excluding odour) shall not cause pollution. The operator shall not be taken to have breached this condition if appropriate measures, including, but not limited to, those specified in any approved emissions management plan, have been taken to prevent or where that is not practicable, to minimise, those emissions.”

The amount of biogas lost to atmosphere has a significant impact on the environment due to its high GWP and therefore a Category 3 non-compliance has been scored against permit condition 3.21. for the exceedance occurring 6th December 2025.
