Conrad Energy

Conrad Energy operates Swansea Power Plant in accordance with EPR AB3393CP. The installation comprises 27 Jenbacher 420, spark ignition natural gas fired engines for the purpose of generating electricity. The Installation is responsible for providing electricity to the National Grid on a short-term basis to meet peak demands. The engines operate for a maximum of 1500 hours per year total.

Annual Report

Operator submitted the sites Annual report on the 21st January 2026. Annual report includes submission for the following parameters:

Operator has submitted the relevant information for the annual parameters required over this period.

Performance Parameters

Performance parameters have been reported in conjunction with annual emission to air monitoring submission. Operator has submitted all the relevant parameters stated in Schedule 4 of the environmental permit, this includes S4.1, S4.2 & S4.3. Reported parameter values are satisfactory.

Emission to Air Returns for A1 to A27 2025

Schedule 3 of the environmental permit outlines the parameters that require monitoring during the annual emissions to air sampling campaign.

Results have been assessed and are compliant with the emission limits, with no breaches

noted.

This CAR report and assessment was undertaken on 26th January 2026. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS system has been altered to 31st Dec 2025.
