## 4. Details of our assessment

### Huntsman Corporation UK Limited

Huntsman Corporation UK Limited operates in accordance with Environmental Permit EPR/BV4223IE.

The installation is a specialist organic chemical plant with an annual production capacity of 37,000 tonnes, located on the former Bynea Steel Works site. The River Loughor runs along the eastern and north-eastern boundaries of the installation.

### Purpose of Compliance Assessment

This Compliance Assessment Report (CAR) reviews the following monitoring returns submitted by the Operator:

- Quarter 4 (Q4): October - December 2024 Point Source Emissions to Water (W1)
- Biannual 2: July - December 2024 Monitoring Returns, Emissions to Air
- Annual Performance Parameters

### Compliance Assessment

Operator has submitted the relevant results for parameters monitored quarterly and biannually during this reporting period. Monitoring returns received, 8<sup>th</sup> January 2026.

### Q4 Point Source Emissions to Water: W1

The Operator submitted the required quarterly monitoring results in accordance with Schedule 3, Table S3.2 of the permit.

All monitoring results have been reviewed and are compliant with the emission limit values set out in the environmental permit.

No breaches were identified

### Bi- Annual 2: July - December 2025 Monitoring Returns, Emissions to Air

The Operator submitted all required biannual air emissions monitoring results, as listed in Schedule 3, Table S3.1.

Assessment of the submitted data confirms that all monitored parameters are compliant with the relevant emission limit values.

No breaches were identified.

### Annual Performance Parameters

The annual performance parameter report was returned alongside the 2025 Q4 monitoring submission.

All required performance parameters have been recorded, and the reported values are considered satisfactory.
