3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

The purpose of report is to assess and record compliance with the Emissions to Water conditions relating to Event Duration Monitoring. On the 19th December 2025 you informed NRW by a Spill Frequency Trigger Exceedance Notification that there had been 21 spills. Condition 3.1.5 (Table S3.1) limits the spills from the asset at 5 in a calendar year.

I have assessed compliance with Condition 3.1.5 (a) and found you to be non-compliant with this condition as the notification was received outside of the required 4 week timescale.

In addition to this the you have not complied with Condition 3.1.5 (b) which requires you to submit a reason for the trigger exceedance along with a any remedial action undertaken or proposed.

Please submit this report to Natural Resources Wales as soon as possible. I have added a month for this to be submitted but ask that DCWW confirm if this date needs to be extended before the deadline is reached.

The full licence Condition 3.1.5 is detailed below:

- a. notify Natural Resources Wales of the Trigger Exceedance as soon as reasonably practicable (and no later than 4 weeks from the date of the Trigger Exceedance) in a format agreed by Natural Resources Wales;
- b. provide a reason for the Trigger Exceedance and a description of any remedial action undertaken or proposed. Where the reason/s for the Trigger Exceedance cannot be identified within the 3 months of the Trigger Exceedance the operator must provide a proposal with timeframes for a full investigation to be carried out to identify the reason/s for the Trigger Exceedance for approval by Natural Resources Wales;
- c. if a full investigation is required by condition 3.1.5 (b), implement the proposal as approved by Natural Resources Wales and provide to Natural Resources Wales a report which identifies the reason/s for the Trigger Exceedance;
- d. submit a plan with timeframes to resolve the reason/s for the Trigger Exceedance identified in 3.1.5 (c) for approval by Natural Resources Wales;
- e. the operator shall implement the plan as approved in condition 3.1.5 (d)
