4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) Regulating Officer (RO) in response to the operator's plans to change the West Factory from painting A380 wings to smaller A320 wings. This was initially discussed at the site meeting on 04/11/25 and with subsequent emails outlining the changes to the painting process and any environmental impacts associated with it.

Several NRW internal discussions were convened with various departments, including the Permitting Team to understand what effect these proposed changes might have on the environment and whether a permit variation would be required. To that end, the operator was requested to provide further information on the following:

- The new painting operation represents a net reduction in VOC and paint overspray emissions;
- You are confident that the existing set-up with regard to the emission points and solvent reduction scheme will not be compromised and is appropriate; and
- There is nothing in the permit or the operating techniques for the West Factory spray booth that relates specifically to the painting of A380 wings.

The operator responded on 08/01/26 with the following answers:

1. The change in painting operations from A380 to A320 will represent a net reduction in VOC and paint overspray emissions. This is due to less product being used than in the A380 painting operations. This is predominantly due to the quantity of paint required per wing dropping from 65 litres to 5 litres. At peak rate the west factory paint shop used 1380 litres of product a month. With the planned rate of 8.5 product usage will be approximately 100 litres per month (92.75% decrease).
2. The paint shop emissions points will not be altered. The solvent reduction scheme will not be compromised due to the same reason as above. Additionally, the equipment used in the paint shop will be more modern and therefore, likely more efficient than the previous A380 painting equipment.
3. The permit does not state anything specific to the painting of A380 wings.

After due consideration, NRW is satisfied that the changes within the West Factory should result in positive environmental outcomes/decreased impacts and a permit variation is not needed at this time. However, the changes to the West Factory will need to be added onto the operators permit with the next permit variation.
