4. Details of our assessmentWestern Bio Energy Limited

Western Bio Energy Limited (WBE) operates the Western Wood Energy Plant in Margam under Environmental Permit EPR/ZP3939GL/V006.

The installation is a co-incineration power plant generating electrical power through the combustion of biomass fuel. The plant has the capacity to process approximately 160,000 tonnes of biomass per annum, producing 14 MW of electricity for export to the National Grid. The facility is permitted to process both virgin wood and waste wood biomass.

Purpose of Compliance Assessment Report

This CAR assesses the following monitoring returns and reports submitted by the operator:

- Quarter 4 (Q4) October – December 2025 Continuously Monitored, Emissions to Air.
- Biannual 2 Periodic Emission Monitoring 2025.
- Quarter 4 Residue Quality.
- 2025 Annual Environmental Report

Quarter 4 2025 Monitoring Returns

The operator submitted Q4 2025 monitoring returns via email on 20th January 2026, this falls within the specified reporting window. Compliant with permit condition 4.2.3.

Q4 2025 Continuous Monitoring- Emissions to Air

Continuously monitored parameters listed in the environmental permit, Schedule 3(b) S3.1 have all been monitored and assessed.

Continually monitored emissions results are compliant with associated emission limits, no breaches recorded.

Biannual 2 2025 Periodic Monitoring Emissions to Air

Biannual 2 2025 Periodic monitoring was undertaken between the 1st and 8th December 2025. Monitoring results has been reviewed and all parameters stated in Table 3.1 of the permit have been monitored. Monitoring results are compliant with the associated emission limits with no breaches noted.

Q4 Residue Quality

Bottom and Fly Ash analysis has been undertaken. Reported results comply with the monitoring requirement of parameters stated in Schedule 3(b) Table S3.5. No breaches of the emissions limit noted.

Annual Environmental Report

Operator submitted its annual environmental report on the 26th January 2026 within stated timeframe, compliant with permit condition 4.2.2.

Environmental report included the sites annual production and all annual performance. All required performance parameters have been recorded, and the reported values are considered satisfactory.

This CAR report and assessment was undertaken on 27th January 2026. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS system has been altered to 31st Dec 2025.
