4. Details of our assessment

This Compliance Assessment Report follows an unannounced inspection at Chirk Particleboard Factory on the 9 January 2026.

Officers met with the Operations Director, CEO and the Logyard Manager.

NRW issued a Regulation 37 Suspension Notice on the 8 January 2026 in relation to the operation of Biomass Boiler K7. The inspection was to ensure compliance with the notice.

Officers visited the control room and confirmed that the shutdown of the K7 boiler had commenced at 16:45 on 8 January 2026. Temperature records were also viewed indicating that the boiler had gone into shutdown following the burn out of the waste on the grate and was in the process of cooling down.

Officers viewed the Biomass Boilers material stock piles in the log yard and visited the walking floor bunker that feeds Biomass Boiler K7. There was residual material within the bunker that had not been loaded into the boiler due to the requirement to suspend the operation.

Officers returned to the site on the 21 January 2026 and confirmed that Boiler K7 remained off.

As per the Suspension notice and following agreement with NRW, the suspension of operation of Biomass Boiler K7 will be temporarily lifted in order to undertake two rounds of simultaneous emissions monitoring at Biomass Boiler K7, Emission point A26, and the relevant MDF cyclones receiving the exhaust gas from Biomass Boiler K7 (either Emission point A29 or A30). The suspension will then be reinstated.
