### 4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised in relation to the Q4 2025 monitoring and waste returns, the bi-annual monitoring returns and annual reports.

#### **Q4 Monitoring Returns - Air**

The Q4 monitoring returns were received on 13<sup>th</sup> January 2026 for emissions from A1 and A12 emission points in compliance with the timescales stipulated in permit condition 4.2.3. The emission point A13 is no longer in use and the site is awaiting a decision on the permit variation to reflect the changes.

Reported parameters were all in compliance with the emission limit values (ELV's) defined in Schedule 3 table S3.1.

#### **Q4 Monitoring Returns - Water**

The Q4 monitoring returns were received on 13<sup>th</sup> January 2026 for discharges from W1 emission point in compliance with the timescales stipulated in permit condition 4.2.3.

Reported parameters were all in compliance with the emission limit values (ELV's) defined in Schedule 3 table S3.2.

#### **Q4 Waste Returns**

The Q4 waste returns were received on 13<sup>th</sup> January 2026 for wastes accepted for the quarter September to December 2025 within the timescale stipulated in permit condition 4.2.5.

The waste returns were reviewed and there were no issues identified.

#### **Bi-annual monitoring of emissions**

The biannual data was submitted on 27<sup>th</sup> January 2026 in accordance with permit condition 4.2.

Reported parameters were all in compliance with the emission limit values (ELV's) defined in Schedule 3 table S3.1.

#### **Environmental Performance Report**

The annual performance report was submitted on 30<sup>th</sup> January 2026 in accordance with

permit condition 4.2.2.

All parameters were reported on as defined in Schedule 4, Tables S4.2 and S4.3. Overall energy efficiency has improved by 1.4% through a reduction in the use of natural gas. This was achieved through a combination of optimised burner performance, changes in product mix, and increased production volumes. Water efficiency has improved by 20% through improved accuracy in water chemical dosing, which has reduced the requirement for system bleed-off, together with improved utilisation of existing water storage to enable greater reuse following works undertaken in the casting pit.
