### 4. Details of our assessment

Routine inspection whilst on site to discuss operation of the sites other transfer licence for the lake. No issues identified with fish screen in place during time of inspection. Work has been undertaken to clear out the sump of silt before the ponds.

We discussed NRW Water Resources Returns and ran through some issues that had been identified during the last returns submission. Officers happy that compliance was being achieved in respect of abstraction quantities.

Condition 1.4.1 of the licence (purpose) currently states the abstraction is to maintain flow through ponds for fish farming. consider updating this to reflect that the fish farm is no longer in operation.

Screen on outflow from pond replaced following site visit.
