4. Details of our assessment

An OSM sample was taken on Wednesday 7 January 2026 and DCWW was notified of a look up table (LuT) exceedance for ammoniacal nitrogen (AMM-N) of 30mg/l vs LuT limit of 20mg/l on 08/01/26 and LuT exceedance for biological oxygen demand (BOD) of 41mg/l

vs LuT limit of 40mg/l on 13/01/2026. This was sent to NRW on 22/1/26 in the format of an Exceptional Circumstances Report which outlined the impacts the recent cold weather had had on the treatment at the works.

On reviewing historic data held for the local area, temperatures were recorded as low as -6 degrees Celsius on several occasions for the days prior to 7 January with daytime temperatures still below freezing:

Based on this data, NRW accepts the unusual temperatures will have affected the treatment of the effluent at Llyswen, and as such agree a waiver for the OSM sample taken on 7th January 2026, in line with permit condition 3.1.3 (a).
