4. Details of our assessment

The purpose of this CAR is to

- record a non-compliance we have identified
- ask you to provide information on when you will come back into compliance.

Record of non-compliance

On the 5 January 2026 you confirmed, via a self-reported pollution incident, that final effluent was being discharged from Southgate Wastewater Treatment Works to the top of Foxhole Bay, Swansea where a recent outfall lining installation had failed.

This discharge is occurring in breach of Permit Condition 2.2.1 which specifies the location the discharge shall take place, notably below mean low water.

*2.1.1 The only activity authorised by the permit is the activity specified in schedule 1 table S1.1.
(Discharge secondary treated sewage effluent via Final Effluent Discharge Point)*

Under Regulation 38 (2) of the Environmental Permitting (England and Wales) Regulations 2016 it is an offence for a person to fail to comply with or to contravene an environmental permit condition.

Please take any advice and guidance given in this CAR as formal.

Coming back into compliance

After a period of similar non-compliances and pollution incidents the outfall was fully lined in May 2025. A record of you coming back into compliance can be found in CAR_NRW0049993.

You have informed us that the lining has failed at one of the hatch boxes on the outfall and the issue has been escalated to your *Capital Team* due to the significant geographical/engineering difficulties presented. At the time of writing this CAR you are unable to provide us with a timeline for rectifying the issue.

Action: By the 27 February 2026, please provide us with a timeline of when the outfall will be repaired and you will come back into compliance.
