4. Details of our assessment

On 28 January I attended Nant Ddu Lodge with colleague Kirsty Allwood for a pre-arranged meeting to discuss the operations on site and the recent improvement works following repeated issues in 2025. We were met on site by the site manager and consultant, thank you both for your time during the inspection.

On arrival we discussed the previous exceedances from 2025 and the root cause behind them - namely the previous sewage contractor failing to follow correct procedures and being unable to deal with the system adequately. You advised that since then a new contract has been arranged that so far appears to be working well.

We then inspected the system to gain a better understanding of the complexities of it, and where the previous issues arose. The system comprises a long series of chambers and many pumps, with ferric dosing at the first attenuation chamber. One of the chambers is also fitted with air blowers to aid aerobic treatment. The final chambers, with the coconut filter medium has been modified as this was causing detriment to the final effluent and is awaiting further consideration from yourselves on the best way forward for this section - the treatment without this filter has so far been good.

It was verbally agreed on site that you would send us a drawing/diagram of the site which would be helpful for us for any future site inspections, please do so when you are able.

As discussed on site, the works you have undertaken so far and have planned are in line with the requirements of the Notice issued 14 July 2025 so we consider this to now be a compliant site.
