4. Details of our assessment

On the 3rd February 2026 Environment Officers Harry Warburton, Leon Handley and Karen

Bowen undertook a compliance inspection of permit AN0419501 for Aberthaw West STW. Accompanied by DCWW pollution technician, catchment manager and performance manager. Weather at the time was light rain with heavy rain preceding.

Inlet and storm tank

This site has a mechanically screened inlet with a static screened overflow bypass channel, this was clear at the time of inspection. Following the inlet the effluent enters a wet well which has a weir once the effluent reaches a certain height, the effluent then enters the storm tank, the EDM MCERTS is located at this point, as well as a monitor for storm tank levels. The storm tank recirculates the effluent during lower inlet flows to be treated. The storm tank was full at the time of inspection and spilling via the bell overflow to the environment due to the sites FPF being above the permitted limit of 29.2l/s from the heavy rain.





Primary treatment

Following the inlet, wet well and storm tank are two primary tanks. The effluent is split evenly between the two and sludge settles in these tanks which then goes to the sludge holding tanks, which are emptied weekly. The primary tanks were in good working order.



Secondary treatment

After the primary tanks the effluent is evenly split between two large rotating filter beds. These were providing a good level of distribution over the filter media. Following the filter beds the effluent is evenly split again in to two final tanks, there was no evidence of any solids carry over.



The final effluent sample point is then at the back of the site and well signposted. The sites logbook was also checked and there was nothing of concern.
