This compliance form is the result of the site inspection carried out on 15/01/2026 by NRW officers Alex Grainger and Hannah Jenkins.

Arrived on site with DCWW at 12:30pm. DCWW lifted the inspection chamber which showed constant flow with no debris / blockages present.



We went down to the lower inspection chamber where this asset is believed to feed into Barry Docks East SPS. This will need to be confirmed with DCWW as to the exact layout of this asset.



According to DCWW storm overflow map, this asset has had no previous recorded spills.
